Please note our 'Terms and Conditions' are as follows:

1. PAYMENT TERMS

Block booking will be invoiced monthly in advance and payment is required within 7 days of date of invoice.

Casual bookings will be payable upon booking via the online booking system, in club or over phone.

2. INTEREST

The club reserves the right to charge interest at the current bank rate plus 2% per month if the invoice is not paid within 7 days.

3. PAYEE

Block booking payments may be made by cash, cheque or credit/debit card. Payment of this invoice when settled by cheque should be made payable to Weston super Mare AFC and sent quoting your Member ID and invoice number to- Accounts Department, Weston super Mare AFC, The Optima Stadium, Winterstoke Road, Weston-super-Mare, BS24 9AA

4. PRICES

The club reserves the right to amend prices from those quoted and as otherwise publicised.

5. CANCELLATIONS

A minimum of 48 hours' notice is required, or payment of the booking will be required in full.

6. BOOKING PERIOD OF THE FACILITY HIRE

Bookings will be made on an hourly basis, but will last for no longer than 55 minutes, to allow for all users to leave and enter the facility hired.

7. CLUB REGULATIONS

The hirer is responsible for ensuring that all persons admitted to the club and grounds for the purpose of the hirer conform to the regulations in force at that time.

8. LITTER

It is the responsibility of the hirer to ensure that ALL litter is picked up at the end of the hire period and placed within the bins provided, failure to do so will result in deposit being withheld.

9. DAMAGE

Any damage caused or loss incurred to the club as a result of, or incidental, to the hiring will be the responsibility of the hirer to pay on demand the costs in full.

10. APPROPRIATE FOOTWEAR

Under NO circumstances will the management allow studded, bladed, dimpled, flat soled or spiked boots to be worn on the 3G. Plastic-studded footwear is the only allowed footwear. No studded or spiked boots to be worn in the clubhouse, OR changing rooms. A copy of appropriate footwear poster is attached.

11. REFUNDS / CREDITS

Refunds or credit notes for fees incurred will be given on a case by case basis.

12. FA GROUND GRADING B

Adjoining Pitches – Where deemed that they are likely to interfere with the playing of a match i.e. balls entering the stadium, referees' whistles etc, ball games must not be played on adjoining pitches whilst a match is in progress.

In the event of a WSMAFC 1st X1 fixture being re-arranged / played, your booking will be cancelled, and an alternative date and time found, or a refund offered.

13. ALCOHOL & FOOD

Under NO circumstances will alcohol or food/soft drink be allowed to be brought on to the 3G pitch facility

14. SMOKING

No smoking is allowed anywhere within the caged 3G pitch facility.
